

**Verification Process for 2009-2010**  
(Request for Information from Students)

The request for information and/or documents from students to complete their financial aid file has begun for 2009-2010 and will continue on a weekly basis.

Financial Aid and Scholarship Awarding for 2009-2010 has begun and will continue on a weekly basis. Check **PCSTAR** at [https://banwebf.calumet.purdue.edu/pls/proddad/twbkwbis.P\\_WWWLogin](https://banwebf.calumet.purdue.edu/pls/proddad/twbkwbis.P_WWWLogin) to see any documents or information required from you, to view your awards and to monitor your financial aid status. **Within PCSTAR:**

1. Select “**Student Services and Financial Aid**” from the Main Menu.
2. Select “**Financial Aid**”.
3. Select “**Aid Eligibility**” then select “**Student Requirements**” to view documents or information required from you.
4. Select “**Important Financial Aid Messages**” to view important messages to you from the Office of Financial Aid.

**Other important information available to you via PCSTAR:**

1. Select “**Overall Status of Financial Aid**” from the Financial Aid Menu.
  - a. Select “**Academic Progress**” to review your current status. If your status is “Probationary” you are at risk of losing your aid eligibility. If your status is “Ineligible” you are currently not eligible to receive financial aid and may submit an Appeal available at the following link <http://www.calumet.purdue.edu/finaid/SAPAPPEAL.pdf>
2. Select “**Aid Eligibility**” from the Financial Aid Menu.
  - a. Select “**Financial Aid Holds**” to view any holds currently existing on your account.

Begin issuing financial aid refunds to students via mail or ACH	August 24, 2009	January 11, 2010

**Special Circumstances**

If your family has experienced a loss in taxable or untaxable income you may be eligible for an adjustment to your aid eligibility. Meet with a financial aid counselor to see if you might qualify for an Appeal based on your Special Circumstances.
