INTERNATIONAL UNDERGRADUATE ADMISSIONS DEADLINES

April 1 - for Summer Semester beginning in June

June 1 - for Fall Semester beginning in August

December 1 - for Spring Semester beginning in January

Your admission file must be complete (all requirements fulfilled) by the deadline for admission to that semester.

INTERNATIONAL UNDERGRADUATE ADMISSIONS NURSING REQUIREMENTS

Nursing Program Applicants: The program has limited enrollment and the best qualified applicants will be considered. Students admitted to the program generally exceed minimum requirements. Applicants must apply early to have a completed file for the **February 1st deadline for the Nursing Admissions Committee**. Applicants approved for admission to the Nursing Program will begin their studies in August.

Deadline for Non-US Transcripts for Nursing Applicants: Transcripts for Non-US secondary school and post secondary school coursework must be official and must be received by December 1st - two months prior to the Nursing Committee deadline in order to have sufficient time for evaluation.

INTERNATIONAL UNDERGRADUATE ADMISSIONS REQUIREMENTS

The following requirements must be met for admission to Purdue University Calumet.

2. You must be a graduate of an accredited secondary school and prove secondary school graduation by submitting official academic transcripts, graduation certificates, and if appropriate true and attested English translations (sent directly from your issuing institution).
3. You must meet the Academic Standards for admission set by Purdue University Calumet's Academic Departments.
4. For admission into a degree seeking major, you **must prove proficiency in the English Language** by achieving one of the following and submitting an official test score report or transcript:
 - a. A **TOEFL** (Test of English as a Foreign Language) score of 550, paper and pencil test, or 79, internet Based TOEFL (iBT).
 - b. A grade of at least a B in English at the ordinary level of **G.C.E.** (General Certificate of Education) or **G.C.S.E.** (General Certificate of Secondary Education).
 - c. A **Scholastic Aptitude Test** (SAT) verbal score of 480 or greater.
 - d. Transferable credit from an accredited US institution of higher education equivalent to Purdue University Calumet's ENGL 104, English Composition course. English 104 equivalents are not guaranteed and are subject to change at any time through the discretion of the Department of English & Philosophy.
 - e. An **IELTS** (International English Language Testing System) Score of 6.5.

Note: If you *did not take or have low English proficiency scores* for entry into a degree seeking major, you may still be eligible for admission into Purdue University Calumet's English Language Program (ELP). If you are interested in ELP, please mark *English Training on the application and English proficiency scores will not be required for admission. All other admission requirements remain the same.*
5. If you have **attended any other college or university and plan to transfer credit hours** to Purdue University Calumet as an undergraduate student, you must complete the Transfer Credit Documentation Sheet (available at www.calumet.purdue.edu/admissions/tcds.pdf), submit a \$30.00 (US) transfer credit evaluation fee, official academic transcripts from an accredited college or university and if appropriate true and attested English translations.

Dear Prospective Student,

As you complete the admission process to Purdue University Calumet, it is essential for you to know that in order to enroll at PUC following admissions that **all international students must provide additional information before an I-20 is issued.**

You will need to submit a letter from your sponsor indicating financial ability and willingness to support your education and living expenses. Additionally, an original letter, true and attested or notarized, from a bank, employer, or financial sponsor also must be submitted, showing assets in American dollars. The necessary amount of financial support is determined by the University and is subject to change. The estimated amount needed for the year in which an application is being made is found in the letter accompanying the application packet.

These documents and any questions regarding the immigration process should be directed to Marsha Gordon - Director of International Student Services CLO Hall 152- Purdue University Calumet - 2200 169th Street - Hammond, IN 46323, (219) 989-2401 or iss@calumet.purdue.edu.

Although admission decisions are made without evidence of financial support, Certificates of Eligibility (either the I-20 form for the F-1 student visa or Form IAP-66 used for the J-1 visa) will not be issued without all admission and immigration documents being submitted and accepted by PUC. The I-20 or the IAP-66 is needed for applying for a Visa at a US Embassy abroad. When all necessary documents for academic consideration are submitted to Admissions and the student has been admitted to Purdue University Calumet and when all necessary immigration documents are submitted and approved - an I-20 will be issued and forwarded to the student. The student will then make application at the appropriate United States Embassy to apply for a visa. The amount of time it takes to secure an appointment, have an interview and be granted a visa varies with each country.

YOU ARE REQUIRED TO REPORT TO CLO HALL, ROOM 152 WITHIN THE FIRST WEEK OF YOUR ARRIVAL, FURNISH LOCAL ADDRESS INFORMATION, TELEPHONE NUMBER AND OTHER IMPORTANT INFORMATION. FAILURE TO PERSONALLY REPORT WITH YOUR PROCESSED DOCUMENTS MAY JEOPARDIZE YOUR IMMIGRATION STATUS.

If you are already in the USA and studying as an F-1 student at another institution, you would follow the same procedures as all students for academic admission. Following acceptance (or during the process of applying to PUC), as a **TRANSFER STUDENT**, you must also submit additional materials including a SEVIS Transfer Form signed by your current institution verifying good standing, copies of all I-20s, passport with all visa pages and I-94 cards, and newly issued financial support documents. It is also your responsibility to complete the transfer process to PUC within the first two weeks of classes. This should be done in person at the International Student Services, CLO Hall, Room 152. You can pick up your I-20 as a transfer student when classes begin.

IF YOU FAIL TO COMPLETE THE TRANSFER PROCESS WITHIN THE FIRST TWO WEEKS AFTER CLASSES BEGIN, YOU RISK BEING OUT-OF-STATUS WITH THE IMMIGRATION & NATURALIZATION SERVICE. THIS MAY NEGATIVELY AFFECT YOUR ABILITY TO APPLY FOR PRACTICAL TRAINING OR OFF-CAMPUS EMPLOYMENT.

As you work your way through all these steps, please be assured that we are here to assist you as much as possible and look forward to having you as a student at Purdue University Calumet.

PROCEDURES REQUIRED FOR SECURING THE I-20 and F-1 STUDENT VISA
(If outside the United States)

Step 1 - Complete all admission requirements for Purdue University Calumet and submit all information to Office of Admissions at www.calumet.purdue.edu/prospective. The process to secure an I-20 cannot begin until you are accepted for admission to the university.

Step 2 - Submit to the International Student Services Office (ISS) financial documentation for proof of financial sponsorship which includes:

- 1) **Original (or true and attested)** financial documents from a bank, employer, or other agency showing funds available for your educational experience at PUC.
- 2) **Original (or true and attested)** letter from sponsor or sponsoring agency indicating willingness to pay all expenses for your educational experience including tuition and fees, room, board and miscellaneous expenses while living in USA.

Financial documents can be no older than 6 months and must be converted to American dollars available and or accessible for expenses for one academic year. **Under no circumstances can we accept faxed, scanned, or photocopies of these documents. They must be originals or true and attested copies. Financial sponsorship support should be in liquid assets, not property or other assets that cannot be converted to cash.**
