- 4.) **Purdue University Calumet** and the **STUDENT ORGANIZATION** agree to indemnify and hold harmless the **SUPPORTER**, its affiliates, officers, employees, and representatives from and against any losses, costs, damages and expenses resulting from claims for bodily injury or property damage or personal injury arising out of the student organization activity of the promotion of such activity, unless such bodily injury, property damage, or personal injury is determined to be the result of the sole negligence of the **SUPPORTER**, its affiliates, officers, employees or representatives.

The **SUPPORTER** agrees to indemnify and hold harmless **Purdue University Calumet** and the **STUDENT ORGANIZATION**, their respective affiliates, officers, employees, and representatives from and against any losses, costs, damages and expenses resulting from claims for bodily injury or property damage, or personal injury arising out of the Student Organization activity or the promotion of such activity, unless such bodily injury, property damage, or personal

Purdue University Calumet Organization, Conditions of Commercial Sponsorship, advertising support, and financial assistance from an outside source.

1. The support as provided by this contract may not imply any connection between Purdue University Calumet and any product, service, agency or business of supporter, nor will any endorsement, expressed, or implied, be allowed of said supporter's product, service, agency or enterprise.
2. All advertising and promotional material related to this event or activity must clearly and dominantly indicate that the Student Organization is the sponsor. An outside source giving significant financial assistance, as determined by Business Office Student Organizations, may be recognized as a supporter through the use of the words "with support from".
3. The sponsoring Student Organization must manage all advertising and promotions. **The Student Organization must clear the copy of all advertising for publications with the student activities and Student Organization area of the Office of the Dean of Students before it is published.**
4. The free distribution on campus of a supporter's commercial product or promotional material at an event or activity that is open to the public is prohibited.
5. The advertising and promotional material of those supporters whose business primarily involves the production, sale, distribution, or serving of alcoholic beverages; or whose advertising message or logo centers on alcoholic beverages, must include a clearly identifiable message from the supporter which promotes responsible drinking.
6. The advertising and promotional material of those supporters whose business primarily involves the production, sale, distribution of tobacco or tobacco products; or whose advertising message or logo centers on tobacco or tobacco products, must include a clearly identifiable Surgeon General's warning about the health risks associated with the use of tobacco.
